- 2. Prayer led by Mr. Ricky A. Gutierrez.
- 3. Review of the Minutes of the Meeting for 7 September 2022.
- 4. ADMIN had a correction on Page 4, Item No. 37 of the Minutes of the Meeting. Instead of "insists" it should be "insisted". The UNION agreed with the correction.
