Please be informed that your application for **Tuition and Other School Fees Increase for Academic Year (AY) 2024 – 2025** is **hereby approved** by CHED to be implemented in view of the provisions of CHED Memorandum Order No. 19 series of 2016, otherwise known as "Benefits and Responsibilities of Autonomous and Deregulated Private Higher Education Institutions", which states that one of the benefits of autonomous HEIs is the "privilege to increase tuition fee without securing a permit from CHED".

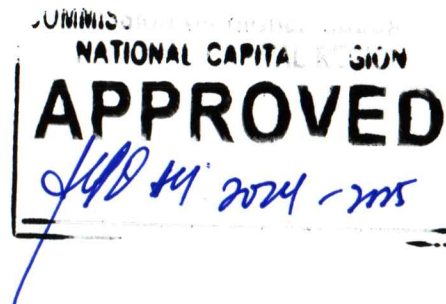
